



## ***Tuition Information for 2025-2026 School Year***

The following are the tuition rates and payment guidelines. Rates are based on an eleven-month schedule, June 2025 through April 2026. Registration fee per child is \$150.00.

## ***Additional Costs***

In addition to school tuition, families are responsible for a lunch fee and a fundraising fee.

### **Lunch Fee Information**

The lunch fee rates will remain unchanged: \$100.00 for one child and \$50.00 for each additional child. **Please note that the rates listed above do not include lunch fees.** Upon registration, the lunch fee will be added to your tuition and distributed over an 11-month period.

### **Fundraising Fee Details**

As we continue to strive for excellence in providing quality education, we are implementing an annual fundraising initiative aimed at minimizing tuition costs for all families.

*Amount:* \$125 per family

*Purpose:* The Fundraising Fee contributes to our mandatory yearly Fundraising Project, designed to help offset tuition costs and maintain affordability for all families.

#### What to Expect:

- Each family will be provided with five (\$25) Lottery calendars as part of their contribution to the Fundraising Project. *Families typically sell the lottery tickets to family and friends or choose to keep them for personal use.*
- We kindly request that you promptly return the stubs for the Lottery calendars.

## **Ways to Save on Tuition at Christ the King**

**We offer several opportunities to make Catholic education more affordable for our families!**

- ♦ **FACTS Grant** – All verified applicants receive a \$205 tuition credit per family, even if they don't qualify for additional aid. Apply here: <https://factsmgt.com/parents/#financial-aid>
- ♦ **Welcome Grants** – Up to \$1,000 per child for new Kindergarten students. Ask our Enrollment Director Merideth about the Welcome Grant during registration!

- ◆ **Transfer Grants** – Students transferring from a public or charter school (Grades 2-7) receive \$1,000 in the first year and \$500 in the second year. Ask our Enrollment Director Merideth about the Transfer Grant during registration!
- ◆ **TuitionCare** – A unique program developed by the Foundation For Catholic Education to help lower tuition costs. Each family can receive up to \$1,000 in tuition credits through the TuitionCare program each year! Learn more: <https://www.tuitioncare.org/join-today>

- ◆ **CTK Script Program** – Purchase everyday gift cards through RaiseRight, and a portion of your spending goes toward lowering tuition. To sign up, call the Rectory at 215-632-1144 for the CTK access code!
- ◆ **CTK Jackpot** – Sell Jackpot tickets to earn tuition credits while supporting the school!
  - Monday night drawings in the School Hall; winners will be contacted via phone call.
  - Earn \$4 off tuition for every 20 tickets sold
  - Tickets are \$1 each with chances to win the Jackpot or a \$500 prize
